

#### CONDITION:

All parts of the object are generally in food conditions without structual damage. However, surface deterioaration (abrasions and substances) and physical damages (cracks and chips) can be seen on the items. The chest piece (C.) and the face piece (A.) are vulnerable on the edges with several damages.


HANDLING NOTES: Handle with both hands using gloves. Special care should be paid attention to when moving and placing the chest piece (C.) and the face piece (A.)
